3. The perusal of the case reveals that the PIO has not provided the complete information to the appellant even after a lapse of 12 months period.

4. In view of the above, a <u>SHOW CAUSE NOTICE</u> under Section 20(1) of the RTI Act is issued to the Public Information Officer O/o Block Development & Panchayat Officer, Patran, District Patiala to exaplain as to why penalty should not be imposed upon him for wilful delay/denial in supplying the information to the RTI applicant and why the compensation be not awarded to the appellant under the provisions of the RTI Act, 2005.

5. The PIO is directed to file reply to the Show Cause Notice and provide the complete information to the appellant and should appear personally in the Commission, on the next date fixed, failing which Rs. 25000/- penaly will be imposed upon him as per provisions of the RTI Act, 2005.

6. The matter is adjourned. To come up for hearing on 11.01.2023 at 11:30 AMin the Commission. Both the parties are directed to present their case personally.
