**ORDER:**

1. This order may be read with reference to the previous order dated 07.09.2022 vide which the absence of the PIO was viewed seriously and it has also affected hearing and disposal of the case. In pursuance of this, the PIO was directed to file a written submission in response to the Notice of the Commission and should present this case personally (through cisco webex), on the next date of hearing, failing which consequences shall follow. A copy of order was sent to him by name through registered post for his ready reference. Matter was adjourned for further hearing on 02.11.2022.
2. In today's hearing, respondent states that information was supplied to the appellant on 03.01.2022 and no discrepancy has been pointed out by the appellant till date.
3. Appellant states that there are discrepancies in the supplied information and he has sent a letter in this regard to the respondent but Sh. Simerjeet Singh denies of receiving the same.
4. After examining the case file, it is observed that no communication is received from the appellant after filing the instant appeal case in the Commission. Accordingly, appellant is advised to send discrepancy letter to the respondent PIO with a copy to the Commission within seven days from today.

Respondent PIO is directed to remove the deficiency as per RTI application within seven days after receipt the discrepancy letter from the appellant.

5. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
