In view of the above, a **SHOW CAUSE NOTICE** under Section 20(1) of the RTI Act is issued to the PIO - cum - SHO O/o Station House Officer, Police Station City -2, Khanna, District Ludhiana, as to why penalty should not be imposed upon him for willful delay/denial in supplying the information to the RTI applicant and why the compensation be not awarded to the appellant under the provisions of the RTI Act, 2005.
