ORDER (SECOND HEARING):

This order may be read with the reference to the order dated 27.09.2022 passed by this Bench on the previous hearing.

2. The Appellant is absent for today's hearing in the Commission.
3. The PIO is again absent for today's hearing and he was also absent on the last hearings dated 27.09.2022, inspite of the Notice/Orders of the Commission. This shows his disregard to the Commission. The absence of the PIO is viewed seriously and it has also affected hearing and disposal of the case.
4. The perusal of the case reveals that the PIO has not provided complete information to the appellant even after the lapse of 11 months' period.
5. In view of the above, a **SHOW CAUSE NOTICE** under Section 20(1) of the RTI Act is issued to the PIO – cum – SHO O/o Station House Officer, Police Station Haibowal, Ludhiana, as to why penalty should not be imposed upon him for willful delay/denial in supplying the information to the RTI applicant and why the compensation be not awarded to the appellant under the provisions of the RTI Act, 2005.

6. The PIO is directed to file a reply to the Show Cause Notice and appear personally, on the next date fixed and provide the complete information to the appellant, before the next date of hearing. In case information as sought by the appellant is not available in the official records, then PIO is directed to file **Undertaking** in this regard and produce the same before the Bench, on the next date of hearing, failing which **penalty of Rs. 25000/-** will be imposed upon him.

7. The matter is adjourned. The come up for hearing on **13.03.2023 at 11:30 AM in the Commission**. Both the parties are directed to present their case personally. Copies of the order be sent to the parties.
