### **ORDER:**

1. The RTI application is dated 27.01.2022 vide which the Appellant has sought information from the PIO O/o Block Development & Panchayat Officer, Block Mehatpur, District Jalandhar in his RTI application.

5. After perusal of the case file and reply sent by the PIO, the Bench is convinced that adequate information stands supplied to the appellant.
6. In view of the above, the Bench does not feel need for further intervention in the matter. Hence, the instant Appeal Case is **disposed of and closed**. Copies of the order be sent to the parties.
