5. In view of the above, the PIO is directed to provide the complete information to the appellant, if any, before the next date of hearing and should present this case personally through Cisco Webex. In case information sought by the appellant is not available in the official records, then PIO is directed to file an **Affidavit/Undertaking** in this regard and produce the same before the Bench, on the next date of hearing, failing which action will be initiated against the PIO as per provisions of the RTI Act, 2005.
