ORDER (FIRST HEARING):

5. The District Development and Panchayat Officer, Ludhiana is also directed to appear personally along with complete record as per RTI application of the appellant on the next date of hearing.

In case the information sought by the appellant is not available in the official records, then both are directed to file an **Affidavit/Undertaking** in this regard and produce the same before the Bench, on the next date of hearing, failing which action under Section 20(1) of the RTI Act, 2005 will be initiated.

7. The matter is adjourned. To come up for hearing on **23.01.2023 at 11:30 AM in the Commission.** Both the parties are directed to present their case personally.
