**ORDER:**

1. The RTI application is dated 21.02.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 28.03.2022 and second appeal was filed in the Commission on 24.05.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act). Notice of hearing was issued to the parties for hearing through CISCO WEBEX on 19.08.2022 but was postponed and fixed for 01.09.2022 and again postponed and is fixed for 01.11.2022 i.e. today.
2. In today's hearing, Ms. Jyotsna Kaur, appellant states that she has received a single page (without any attachments) on 20.08.2022 and further requests for information.
3. None is present from the department in spite of registered post notices issued by the Commission, which is a sheer wastage of precious time and resources of the Commission. One more opportunity is awarded to the concerned PIO to supply the point-wise information to the appellant through registered post within seven days after receipt of this order, failing which stern action will be initiated against the PIO concerned.
4. Appellant is also advised to point out discrepancy, if any, in writing to the respondent PIO within seven days after receipt of information with a copy to the Commission, failing which it will be presumed that she has nothing to say in this regard.
5. With the aforesaid directions, the matter is adjourned to **25.01.2023 at 11:00 A.M. through CISCO-Webex (Video Conferencing application)**. Copy of the order be sent to the parties. (Steps to use CISCO WEBEX: Install CISCO Webex->Click on Join Meeting->Enter Meeting Number 1582933632).
