5. In view of the above, a **SHOW CAUSE NOTICE** under Section 20(1) of the RTI Act is issued to Er. Jatinder Singh Chhina, XEN – cum – PIO O/o XEN/Executive Engineer, Electrical Division, PWD (B & R), Jalandhar, as to why penalty should not be imposed upon him for wilful delay/denial in supplying the information to the RTI applicant and why the compensation be not awarded to the appellant under the provisions of the RTI Act, 2005.

6. The PIO is directed to file a reply to the Show Cause Notice and appear personally, on the next date fixed and provide the complete information to the appellant, before the next date of hearing. In case information as sought by the appellant is not available in the official records, then PIO is directed to file an Affidavit in this regard and produce the same before the Bench, on the next date of hearing, failing which **penalty of Rs. 25000/-** will be imposed upon him.

7. The matter is adjourned. The come up for hearing on **30.11.2022 at 11:30 AM in the Commission**. Both the parties are directed to present their case personally. Copies of the order be sent to the parties.
