ORDER (FIRST HEARING):

The RTI application is dated 11.03.2022 vide which the Appellant has sought information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (hereinafter FAA) on 11.05.2022 and Second Appeal was filed in the Commission on 21.06.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and Notice of hearing was issued to the parties for 11.10.2022.

2. The Respondent appears in person and hands over the requisite information to the appellant whereas the Appellant, after going through the documents, states that relevant information has not been provided to him.

3. In view of the above, the Appellant is advised to point out the deficiencies in writing to the PIO within week. The PIO is also directed to remove the deficiencies after receiving the same from the appellant.

Joginder Kaur, Deputy Director – cum – PIO O/o Rural Development & Panchayat Department, Punjab is directed to provide complete information to the appellant if available in the official records. In case information sought by the appellant is not available in the official records, then PIO is directed to file an **Affidavit/Undertaking** in this regard and produce the same before the Bench.
