4. The PIO should present this case personally through Cisco Webex. In case information as sought by the appellant is not available in the official records, then PIO is directed to file an **Undertaking** in this regard and produce the same before the Bench, on the next date of hearing, failing which action will be initiated against the PIO as per provisions of the RTI Act, 2005.

5. The Appellant is also directed to follow up his case in the Commission, failing which decision shall be taken on merits.
