### **ORDER (FIRST HEARING):**

The RTI application is dated 27.04.2022 vide which the Appellant has sought information as enumerated in his RTI application. 5. The PIO is also directed to facilitate him and provide the requisite information to the appellant on the spot. In case the information as sought by the appellant is not available in the official records, then PIO is directed to file an **Undertaking** in this regard and produce the same before the Bench, on the next date of hearing, failing which action under Section 20(1) of the RTI Act, 2005 will be initiated.
