3. The Respondent states that remaining information pertains to the Markfed District Office Sangrur because District Barnal has come into existence in the year 2015, as such, the demanded information is not available in the officials' records.

4. In view of the above, information sought has to be provided by the PIO O/o District Manager, Markfed, District Sangrur hence the PIO O/o District Manager, Markfed, District Sangrur is impleaded as Respondent No. 2.

5. The PIO O/o District Manager, Markfed, District Barnala is directed to retrieve the requisite information from the concerned office and provide to the appellant, before the next date of hearing.

6. The PIO O/o District Manager, Markfed, District Sangrur is also directed to provide the remaining information to the appellant. In case the information as sought by the appellant is not available in the official records, then PIO is directed to file an **Undertaking** in this regard and produce the same before the Bench, on the next date of hearing, failing which action under Section 20(1) of the RTI Act, 2005 will be initiated.
