**ORDER**

1. The RTI application is dated 30.04.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereafter FAA) on 04.06.2022 and second appeal was filed in the Commission on 29.07.2022 under Section 19 of the Right to Information Act, 2005 (hereafter RTI Act).
2. Notice of hearing was issued to the parties for hearing on 02.11.2022 through CISCO WEBEX i.e. today.
3. In today's hearing, respondent, Sh. Dharun states that information as per official record had already been supplied to the appellant.
4. On this, appellant states that incomplete information has been supplied to him and information in connection with point no. 3 and 4 is still pending.
5. After discussing with both the parties in detail, appellant is advised to visit the respondent's office and contact respondent, Sh. Dharun to inspect the official record and obtain the information; and the respondent PIO shall provide copies thereof, according to his RTI application, within a fortnight, in accordance with the relevant provisions of the RTI Act, 2005. Respondent PIO is directed to cooperate with the appellant on his visit.
6. Both the parties are advised to represent this case in person on the next date of hearing, failing to which, appropriate order in their absence shall be passed.
7. To come up on **19.01.2023 at 11:00 A.M. through CISCO-Webex** (Video Conferencing application). Copy of the order be sent to the parties.
