ORDER (FIRST HEARING):

The RTI application is dated 24.05.2022 vide which the Appellant has sought information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (hereinafter FAA) on 12.07.2022 and Second Appeal was filed in the Commission on 03.08.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and Notice of hearing was issued to the parties for 06.12.2022.

In case information as sought by the appellant is not available in the official records, then PIO is directed to file an **UNDERTAKING** in this regard and produce the same before the Bench, on the next date of hearing, failing which action will be initiated against the PIO as per provisions of the RTI Act, 2005.
