ORDER (FIRST HEARING):

The RTI application is dated 22.04.2022 vide which the Appellant has sought information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (hereinafter FAA) on 30.05.2022 and Second Appeal was filed in the Commission on 03.08.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and Notice of hearing was issued to the parties for 06.12.2022.

2. The Appellant states that incomplete information has been provided to him.

3. The Respondent states that requisite information has already been supplied to the appellant except point no. 2 of the RTI application of the appellant which is not available in the official records.

4. **Last and final opportunity** is given to the PIO to provide the remaining information to the appellant, if any, before the next date of hearing and should present this case personally in the Commission. In case information as sought by the appellant is not available in the official records, then PIO is directed to file an **AFFIDAVIT** in this regard duly attested by the Notary Public and produce the same before the Bench, on the next date of hearing, failing which action will be initiated against the PIO as per provisions of the RTI Act, 2005.
