### **ORDER (FIRST HEARING):**

The RTI application is dated 06.06.2022 vide which the Appellant has sought information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (hereinafter FAA) on 08.07.2022 and Second Appeal was filed in the Commission on 22.08.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and Notice of hearing was issued to the parties for 19.12.2022.

2. The Appellant states that incomplete, irrelevant information has been provided to her whereas the Respondent states that requisite information has already been provided to the appellant in other case also.

4. After hearing both the parties, the PIO is directed to appear personally in the Commission along with entire record related to the RTI application dated 06.06.2022 of the appellant, on the next date of hearing, failing which **strict action** will be initiated against the PIO as per provisions of the RTI Act, 2005.
