ORDER:

The RTI application is dated 18.05.2022 vide which the Appellant has sought information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (hereinafter FAA) on 22.06.2022 and Second Appeal was filed in the Commission on 23.08.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and Notice of hearing was issued to the parties for 20.12.2022.
