ORDER (FIRST HEARING):

The RTI application is dated 23.04.2022 vide which the Appellant has sought information as enumerated in his RTI application. 4. The PIO is again directed to supply remaining information to the appellant. In case information sought by the appellant is not available in the official records, then PIO is directed to file an **Undertaking** in this regard and produce the same before the Bench, on the next date of hearing, failing which action will be initiated against the PIO as per provisions of the RTI Act, 2005.

5. The District Development and Panchayat Officer, Jalandhar is also directed to ensure compliance of the order from his respective subordinates, before the next date of hearing.
