## **APPEAL CASE NO. 4190 OF 2022** **(Cisco Webex Proceedings)**

### **ORDER:**

1. The RTI application is dated 31.05.2022 vide which the Appellant has sought information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (hereinafter FAA) on 19.07.2022 and Second Appeal was filed in the Commission on 08.09.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and Notice of hearing was issued to the parties for 07.02.2023.
2. The Respondent states that requisite information has already been sent to the appellant on 06.02.2023 whereas the Appellant states that he has not received yet.
3. In view of the above, the Respondent is directed to send immediately this information to the appellant on his Whats App number. Subsequently, on perusing the information the Appellant states that incomplete information has been supplied. Accordingly, he is advised to point out the deficiencies in writing to the PIO. The PIO is directed to remove deficiencies pointed out by the appellant, if any, and supply rectified information, under intimation to the Bench, before the next date of hearing.
4. In case the information as sought by the appellant is not available in the official records, then PIO is directed to file an **Undertaking** in this regard and produce the same before the Bench, on the next date of hearing, failing which strict action will be initiated against him/her as per provisions of the RTI Act, 2005.
5. The matter is adjourned to **24.04.2023 at 11:00 AM through CISCO WEBEX MEETING ID No. 158 188 4645**. Both the parties are directed to come to attend the hearing accordingly. Copies of the order be sent to the parties.
