## **APPEAL CASE NO. 4650 OF 2022**

### **ORDER (FIRST HEARING):**

1. The RTI application is dated 28.03.2022 vide which the Appellant has sought information as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (hereinafter FAA) on 28.04.2022 and Second Appeal was filed in the Commission on 04.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and Notice of hearing was issued to the parties for 01.03.2023.
2. The Appellant states that information sought has not been provided to him.
3. Since the PIO is absent, he is contacted on his mobile phone. He requests that some more time be given him to provide requisite information to the appellant.
4. On the request of the PIO, **LAST OPPORTUNITY** is given him to supply requisite information to the appellant, before the next date of hearing. In case the information as sought by the appellant is not available in the official records, then PIO is directed to file an **Undertaking** in this regard to the appellant and produce the same before the Bench, on the next date of hearing, failing which **PENALTY** will be imposed upon him as per provisions of the RTI Act, 2005.
5. The District Development and Panchayat Officer, Sangrur is also directed to ensure compliance of the order from his respective subordinates, before the next date of hearing.
6. The matter is adjourned to **26.04.2023 at 11:00 AM through CISCO WEBEX MEETING ID No. 158 188 4645**. Both the parties are directed to come to attend the hearing accordingly. Copies of the order be sent to the parties.
