3. In view of the above, the appellant is again advised to be send deficiencies in writing to the PIO within week, under intimation to the Commission. The PIO is also directed to remove the deficiencies to be pointed out and supply rectified information to the appellant, before the next date of hearing. In case the information sought by the appellant is not available in the official records, then PIO is directed to file an **Affidavit/Undertaking** in this regard and produce the same before the Bench, on the next date of hearing, failing which action will be initiated against the PIO as per Section 20 (1) of the RTI Act, 2005.

6. The matter is adjourned. To come up for hearing on **25.01.2023 at 11:00 AM through CISCO WEBEX MEETING ID No. 158 188 4645**. Both the parties are directed to present their case accordingly.
