2. The RTI request is dated 24.05.2021. The complaint has been received in the Commission on 17.01.2022.
3. This case was last heard on 16.01.2023.
4. The complainant, Sh. Jaspal, appeared in person in today's hearing, states that no information has been given to him by the respondent PIO till date.
5. Neither the respondent PIO nor any of his representative is present in today's hearing.

After going through the case-file, it emerges that the respondent PIO or any of his representative was never appeared before the Commission on the fixed hearings, held on 13.06.2022, 01.08.2022, 27.10.2022, 25.11.2022 and 16.01.2023. Moreover, the respondent PIO has not sent any document, which shows that the penalty amount of Rs. 15,000/- imposed vide orders dated 25.11.2022, has been deposited or not.

As grave negligence has been made on the part of respondent PIO by not complying various orders passed by the Commission, so a Bailable warrant be issued to PIO office of Panchayat Secretary, Gram Panchayat, Bhindi Aulakh Khurd, Block - Chaugawan, Tehsil – Ajnala, Distt.- Amritsar for the appearance of the concerned PIO on the next date of hearing with the directions to the respondent PIO to comply with the earlier order by depositing penalty amount of Rs. 15,000/- which was imposed vide orders dated 25.11.2022 in the Treasury and submit a challan-receipt to the Commission.

7. A copy of this order be sent to the Commissioner of Police, Amritsar through registered post for the appearance of the concerned PIO on the next date of hearing.

With this, the case is adjourned to 22nd March, 2023 at 12:00 P. M. for hearing.
