2. The RTI request is dated 16.12.2021. The complaint has been received in the Commission on 08.07.2022.

Ms. Rajwinder Kaur, Head Constable, who appeared on behalf of the respondent PIO in today's hearing, states that the status report on the request letter dated 10.07.2019 filed by the appellant (regarding which the information sought) has been collected from office of S.H.O., Phase – 11, Mohali and the same has been given to the applicant.
5. The complainant, Sh. Hardev Singh, who appeared in person in today's hearing, states that he has received the information but alleges that the respondent PIO has made inordinate delay in supplying the requisite information to him and demands that penal action should be taken against the concerned respondent PIO under Section 20 (1) of the RTI Act and disciplinary action be recommended under Section 20 (2) of the RTI Act against the PIO.
