Hence, the instant complaint case is <u>remanded to First Appellate Authority</u>, office of Sohana Hospital, Sohana with the directions to decide the case as per provisions of the RTI Act, after giving due opportunity to the parties concerned, examining the evidences, documents placed on record/submitted by the parties concerned and subsequently pass a speaking order within forty five days from the receipt of this order. A copy of the RTI request of the applicant be also enclosed for ready reference of First Appellate Authority, who will treat it as first appeal. If concerned First Appellate Authority will not announce any order in the instant complaint case within forty five days or if the complainant would not be satisfied with the decision/announcement (which would be announced) by the First Appellate Authority, he is at liberty to approach the Commission by way of second appeal.
