ORDER:

The RTI application is dated 12.06.2018 whereby the Complainant has sought information as mentioned in his RTI application. He filed complaint in the Commission on 04.04.2022 under Section 18 of the Right to Information Act, 2005 (hereinafter RTI Act). The notice of hearing was issued to the parties for 31.05.2022.

2. The aforesaid complaint case was remanded back by this Bench to First Appellate i.e. Inspector General of Police, Ludhiana Range, Ludhiana vide order dated 31.05.2022. But the appellant vide letter dated 21.06.2022 has alleged non-compliance of the orders of the Commission by the First Appellate Authority, as such this request of appellant is treated as Second Appeal.

3. On the request of the appellant, his complaint case has been converted into Appeal Case. Accordingly, the notice of hearing was issued to the parties for 07.12.2022.

4. The Appellant states that information sought has not been provided to him.
5. The Respondent states that information sought by the appellant is lying in the office of Senior Superintendent of Police, Tarn Taran and a letter has been written to provide complete information to the appellant relating to his RTI application dated 12.06.2018.
6. In view of the above, the PIO is directed to retrieve the requisite information from the PIO O/o S.S.P. Tarn Taran and provide complete information to the appellant, before the next date of hearing.
7. Since, the information is to be provided by the PIO O/o Senior Superintendent of Police, Tarn Taran. I, therefore, order that PIO O/o Senior Superintendent of Police, Tarn Taran be impleaded as Respondent No. 2. I further direct that PIO O/o Senior Superintendent of Police, Tarn Taran should supply the information to the Appellant, before the next date of hearing.
8. Both the aforementioned PIOs are directed to provide the complete information to the appellant, before the next date of hearing and should appear personally on Cisco Webex, on the next date of hearing, failing which action under Section 20(1) of the RTI Act, 2005 will be initiated.
9. The matter is adjourned to **21.03.2023 at 11:00 AM through CISCO WEBEX MEETING ID No. 158 188 4645**. Both the parties are directed to present their case accordingly. Copies of the order be sent to the parties.
