Viewing the defying attitude towards dealing the RTI application, **Sh.Charnajit Singh Panchayat Secretary** cum PIO Gram Panchayat Siswa, Block Majri, SAS Nagar is, thus, issued a show cause notice to explain in a self-attested affidavit as to why a penalty @ Rs.250/per day of delay subject to a maximum of Rs.25000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on his for causing willful delay/denial of the information to the RTI applicant and to show cause why a compensation under section 19(8) o-f the RTI Act,2005, may not be paid to the appellant for causing willful delay/denial of the

information for detriment suffered by him. In addition to the written reply, the Public Information Officer is also given an opportunity under Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may take a note that in cas-e he does not file his written reply and does not avail himself of the opportunity of personal hearing on the next date, it will be presumed that he has nothing to say and the Commission will proceed ex-parte, on merit.

- 6. That the PIO is hereby directed to submit response/supply the sought information to the appellant before the next date of hearing and further directed to remain present on the next date of-hearing. The case is adjourned.
- 7. To come up on 10.04.2023 at 12.30 P.M. to be heard through video conference facility available in the office of the Deputy Commissioner, Patiala.
