ORDER:

*(To be read in continuity with earlier orders on 9.4.2021, 12.8.2021, 8.10.2021, 9.11.2021, 23.2.2022, 27.5.2022, 2.11.2022, and 16.12.2022)*

1. The RTI application is dated **4.9.2020** vide which the appellant has sought information **regarding the MC Building in Zone C**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **17.10.2020** and Second Appeal was filed in the Commission on **18.12.2020** under Section 19 of the Right to Information Act, 2005. The case was last heard on **16.12.2022**.

2. At the last hearing on 16.12.2022, Bailable Warrant was issued against Sh. Amandeep Singh, Clerk, Sale and Rent, to ensure his presence at the hearing on 3.2.2023.

3. Sh. Amandeep Singh appeared before this Bench in person today. He states that he has neither received Show Cause Notice issued to him by this Commission's Order of 2.11.2022 and nor was he provided a copy of RTI application by the PIO-cum-Superintendent Tehbazari, Zone C, Sanjeev Uppal, as directed accordingly vide this Commission's Order of 27.5.2022.

4. In view of Sh. Amandeep Singh's contention and the fact that he is voluntarily present before this Bench. The Bailable Warrant issued against him is hereby withdrawn. Sh. Amandeep Singh is hereby directed to submit that part of the information of this RTI application which pertains to his Branch, to this Commission on or before the next hearing. Said information must be accompanied by a covering letter, including pointwise reply and the requisite information by way of duly attested copies.
