ORDER:

*(To be read in continuity with earlier orders on 18.5.2021, 11.8.2021, 26.10.2021, 23.11.2021, 30.11.2021, 20.6.2022,, 23.8.2022, and 5.12.2022)*

1. The RTI application is dated **12.9.2020** vide which the appellant has sought information **regarding Police Station Division No. 4, Ludhiana, 1.1.2020 to 31.8.2020**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **12.10.2020** and Second Appeal was filed in the Commission on **11.1.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard by Full Bench on **5.12.2022**.

2. The appellant is absent but has informed the Commission of his inability to attend today's hearing. The respondent PIO-cum-SI, Division No. 4, Ludhiana, is present in person.

3. The PIO has submitted proof of payment for the penalty imposed upon him by this Commission's Order of 23.8.2022, vide Letter No. 328 Dated 22.9.2022. the PIO has also presented a copy of the reply to the RTI application that was sent to the appellant. In the reply presented during hearing, it was the PIO-cum-SHO's contention that the information requested in this RTI application which is as under:-

“1. Serialized list and certified copy of the roads number issued by PS Division No. 4 to RTA, Ludhiana from 1.1.2020 to 31.8.2020.

2. Certified copies of the register whereon road number issued to RTA, Ludhiana from 1.1.2020 to 31.8.2020 entered.”

is not available since no road numbers are directly issued to the RTA, office by Police Station Division No. 4, Ludhiana. Accordingly, the information sought at point no. 2 of the RTI application was also stated to be nil. During today's hearing, SIC Sh. Asit Jolly, expressed his intention to recues from this Appeal Case.
