

- 2. Both parties are present. The respondent PIO, represented by Sh. Harry Boparai, SHO Police Station Kotwali Nabha and Sh. Amandeep Singh, Senior Assistant from SSP, office Patiala, are present. The appellant is accompanied by her husband Sh. Raj Singh. The PIO-cum-SHO, PS Kotwali Nabha has submitted a reply to the Show Cause Notice issued to him vide this Commission's Order of 6.12.2022. Two separate replies have been submitted by way of information as directed by the Commission first vide Letter No. 2567 Dated 20.12.2022 from the PIO-cum-SP, Patiala with a pointwise reply and the information as available in his record.
