After examining the documents placed on record, it is found that the respondent PIO through a reply vide letter no. 1629 dated 22.09.2022 (received in the Commission vide Diary No. 22324 dated 30.09.2022), has intimated the Commission that the information, demanded by the appellant through RTI request relates with office of State Council of Education and Research, Punjab, S. A. S. Nagar, hence, the RTI request of the appellant was transferred to that office under Section 6 (3) of the RTI Act. It is taken on record.

5. Ms. Karamjit Kaur, Senior Assistant, who appeared on behalf of the respondent PIO in today's hearing, submits a letter dated Nil intimating that the information sought through RTI request does not relate with their office i.e. Director, State Council of Education and Research, S. A. S. Nagar. The same is taken on record.

6. The appellant, Sh. Vipin Kumar is not present in today's hearing.

7. It is observed that the appellant Sh. Vipin Kumar has not attended any hearing in the Commission. I am, therefore, of the considered view that no useful purpose would be served by prolonging this matter any further.

8. In view of the above, no further cause of action is left, hence the above said appeal case filed by the appellant is **disposed of and closed**. *However, the appellant is advised to file fresh application with the concerned department, if he wish so.* Copies of the orders be sent to the parties.
