## <u>ORDER</u>

5. The Respondent has filed a copy of the reply along with the copy of notings and documents relating to the RTI of the appellant. Further, regarding the copy of complaint dated 18.04.2022, as sought by the Appellant. I fail to understand as to how the appellant seeking the copies of his own complaints/appeals. It is needless to say that if the appellant does not have copies of his own complaints/ appeals he has to blame himself and he cannot seek those complaints/appeals as a matter of Right. Further, those documents cannot bring under the definition "information" as defined under Section 2(f) of the RTI Act 2005.

6. In view of the above, no further cause of action is left. Hence, the Appeal case filed by the Appellant is **disposed off and closed**. Copy of orders be sent to the parties.
