Nevertheless, both the parties i. e. the appellant and the respondent PIO are directed remain present with the information (already/would be supplied in the instant appeal-case) during the proceedings of the instant appeal-case on the next date of hearing fixed before the bench of the undersigned in the office of State Information Commission, Punjab or the case would be decided on merits.

With this, the case is **adjourned to 30th November, 2022 (Wednesdday) at 12:00 P. M. for hearing.**
