ORDER

Further PIO, o/o DGP Punjab transferred the RTI of the appellant to PIO, o/o SSP, Amritsar (rural). Sh. Manjit Singh, ASI is appearing on behalf of the office of SSP, Amritsar and has sought some time.

4. After hearing both the parties and going through the case file, it is observed that the information is lying with the PIO, o/o SSP, Amritsar (Rural).
