2. The representative of the appellant submits the authority letter to appear on behalf of the appellant which is accepted by the Commission. The representative of the appellant states that information has not been supplied by the PIO so far.

3. The respondent present reiterates that the information relates to PIO o/o Tehsildar Ajnala. Sh. Veerkaran Singh PIO cum Tehsildar Ajnala who is not present today due to health issues. However, he has submitted a letter dated 05.01.2023 to the Commission through email along with the reply to the show cause notice issued to him which is taken on record.
