Order

The RTI Application is dated 08.10.2022 vide which the appellant has sought information regarding detail of Khasra Numbers included in Green Land Avenue Colony Village Rakhshikargah Tehsil Amritsar-2 which is written on the proposed Collector Rate 2021-11 at Sr. No. 16 etc. as enumerated in his RTI Application. First Appeal was filed with the First Appellate Authority (hereinafter called FAA) on 22.11.2022 and Second Appeal was filed in the Commission on 03.1.2023 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The appellant states that information has not been provided by the respondents.

3. The PIO has sent a letter no. 106-07 dated 28.2.2023 to the Commission which is taken on record. The PIO reiterates the written submissions that Khasra numbers of Green Land Colony is not included in village Rakhshikargah. He further submits that Khasra nos. of private colony can be obtained from Municipal Nagar Nigam, Amritsar.

4. In view of the above the Tehsildar Amritsar-2 cum PIO is directed to search his record to take the matter to its logical end and transfer RTI application to PIO o/o Municipal Nagar Nigam, Amritsar u/s 6(3) of the RTI Act, 2005. Accordingly, the PIO o/o Municipal Nagar Nigam, Amritsar is impleaded as necessary party in this case. The PIO o/o Municipal Nagar Nigam, Amritsar is directed to submit response/ provide information to the appellant before the next date of hearing. A copy of RTI application along with the letter dated 28.2.2023 issued by the Sub-Registrar, Amritsar-2 is being sent to the PIO o/o Municipal Nagar Nigam, Amritsar.

5. To come up on 10.04.2023 at 11.00 A.M. to be heard at video conference facility available in the office of the Deputy Commissioner, Amritsar.
