Order

The RTI Application is dated 13.07.2022 vide which the appellant has sought the information regarding 1) Educational qualifications of Principals and Directors of Mount Carmel Schools in the jurisdiction of DEO(SE), Hoshiarpur along with the eligibility and recruitment process of Principals etc. as enumerated in his RTI Application. 2) Information regarding not appointment of post of principal belonging to Punjab State. 3) Information of teachers / Principal appointed by way of promotion or other way in said schools 4) Information that every principal having appropriate educational/degree for the post of principal. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 18.8.2022 and Second Appeal was filed in the Commission on 26.10.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today.

2. The representative of the PIO states that information has been provided to the appellant through letter bearing no. 20754 dated 23.1.2023. The PIO has sent an email along with the information to the Commission which is taken on record.

3. The appellant states that incomplete and misleading information has been provided by the PIO. The appellant has sent an email to the Commission which is taken on record.

4. After deliberation with the parties, the appellant is hereby directed to clarify the information sought his RTI application pertaining to point no. 2 and 4 and also establish public interest in seeking information pertaining to point no. 3 before the next date of hearing.

5. The PIO is directed to clarify the meaning of equivalent in column no. 7 in the statement enclosed with the letter dated 23.1.2023 before the next date of hearing.

6. To come up in 09.03.2023 at 12.30 P.M. to be heard through video conference facility available in the office of the Deputy Commissioner, Hoshiarpur.
