## Appeal Case No. 4312/2022

### ORDER

The RTI application is dated 2.7.2022 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 26.7.2022 and second appeal was filed in the Commission on 15.9.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for 11.11.2022. But the case could not be heard on the said date and further adjourned for today.

2. The appellant has sought the following information as per his RTI application:-

3. The appellant is absent without intimation. However, the specific reply has already been received from the respondent, which is taken on record. After consideration, the reply of the respondent is accepted and the Commission is of the view that no further action is required to be taken in this case. A copy of the reply filed by the respondent is **being sent** to the appellant along with this order. Hence, the case is disposed of and closed.
