ORDER

Heard through facility of Software/application 'CISCO Webex Meetings'.

The RTI request is dated 29.12.2018. First appeal is dated 15.03.2019. Second appeal has been received in the Commission on 20.06.2019.

On the last date of hearing, held on 02.11.2020, final opportunity is given to the respondent PIO concerned either to supply certified copies of the required information to the appellant or send a written reply in the shape of an affidavit to the appellant mentioning that the required information is not available in the official record or has gone missing, mentioning the reasons whether official record is missing or destroyed or whether any FIR has been lodged regarding missing record or copy of FIR (if the record is missing) or copy of Office-order (if destruction of record has been done) with a copy to the Commission. A show cause notice under Section 20 (1) of the RTI Act was issued to Public Information Officer concerned of office of Secretary, Regional Transport Authority, Patiala under the provisions of the RTI Act, 2005.

The appellant, Sh. Prem Singh, who appeared in person in today's hearing, states that no information has been supplied to him by the respondent PIO till date.

Sh. Sham Lal, Assistant Transport Officer-cum-PIO, who appeared in person in today's hearing, states that the appellant has demanded information regarding STR 17 schedule of GPF deductions made from his salary for the month of November, 2011 (paid in December, 2011) and relevant record is lying with the Head Office i. e. office of State Transport Commissioner, Punjab, Chandigarh as his service-book is in the Head Office and a reply has already been sent to the appellant vide letter no. 89 dated 12.10.2020 with a copy to the Commission. It is taken on record.

He further states that a committee consisting of four officials was constituted to find out the record demanded by the appellant and efforts have been made to locate the record but was not found available in the official record and a reply has again been sent to the appellant vide letter no. 89 dated 12.10.2020 with a copy to the Commission. It is taken on record.

As missing of service-record of a Government employee is serious matter, hence, oral-submission (made by Sh. Sham Lal, Assistant Transport Officer-cum-PIO during the hearing) as well as written-submission(sent by Sham Lal), i. e. after more than one year of the proceedings of this case, is not acceptable.

Accordingly, an opportunity is given to the respondent PIO to put in more efforts to trace out the relevant official record and directed either to supply certified copies of the required information as per queries raised by the appellant through RTI request, to the appellant or if the required information is not found available in the official record, he/she (the respondent-PIO concerned) will send a proper written reply in the shape of an affidavit to the appellant through registered post with a copy to the Commission, stating that the required information is not available in the official record or has gone missing. If the record is missing, whether any FIR has been lodged regarding missing record. If any FIR is lodged regarding missing record, a copy of FIR be sent to the Commission alongwith with affidavit to the Commission positively, by the next date of hearing.

The case is adjourned to 4th May, 2021 (Tuesday) at 11:00 A. M. for hearing through facility of Software/application 'CISCO Webex Meetings'.

An opportunity is given to the appellant to confirm whether he has received the
information (which would be supplied by respondent PIO) or not by the next date of hearing.

An opportunity is also given to the appellant to confirm whether he has received the information, which would be supplied to him by the respondent PIO after inspection, or not and also to point out deficiencies, if any, in the information supplied to him, in writing, to the respondent PIO well in time so that the same could be removed by the respondent concerned by the next date of hearing.
