

The Bench observes that the PIO, O/o Secretary, , Regional Transport Authority, Jalandhar was impleaded as respondent No.2 on the previous hearing and was directed to provide the information regarding the outcome of enquiry entrusted to the Secretary, Regional Transport Authority, Jalandhar, to the appellant.
