3. The complainant states that he has received the complete information and is satisfied with the same. He further states that a penalty may be imposed due to delay in supplying the information. He also states that the officials are also looking after the additional duties related with Covid 19 pandemic and requested to close the case.

Officer states that the amount of compensation has already been paid to the appellant through his personal account and a request has been raised to take the refund of the said amount. He has also placed on record a copy of the submissions sent to the Block Development and Panchayats Officer for refund of the amount, which is taken on record. He has also placed on record a copy of the cheque submitted by the respondent-Public Information Officer, which is taken on record. The appellant also states that he has received the compensation amount. He has also sent an email vide which the screen shots of a website has been taken on record and alleged that the respondents have not supplied the complete information. Thereafter, the respondent-Public Information Officer states that the appellant has already supplied a copy of the bank statement and cash book, hence, no information has been hidden from the appellant. He further clarified that all the government grants being received through banks only.

4. Keeping in view the above submissions of both the parties, the Commission observes that no further action is required to be taken with regard to supply the information to the appellant in this case as the complete information has already been supplied as available in the official record of the respondents.

5. The respondent-Public Information Officer-cum-Panchayat Secretary Sh. Chanda Singh is directed to place on record a documentary evidence that he has taken the refund of the compensation amount from State Exchequer before the next date of hearing.
