- 1. This order may be read with reference to the order dated 07.03.2022 passed by this Bench on the previous hearing.
- 2. The case has been heard today. The appellant, Shri Tejinder Singh comes present to attend the hearing through Cisco Webex. He states that he has been sent letter dated 07.03.2022 whereby a notice has been issued to the owner of SCF No.143, Dhandari Kalan, Phase-1 & 2, Ludhiana whereas he has been not supplied copies of the plans asked for and as such, the order of the Hon'ble Commission still remains to be complied with..
- 3. Neither the PIO has come present nor he has deputed any of his representatives to attend the hearing in person or through cisco webex.
- 4. - 1. This order may be read with reference to the order dated 26.04.2022 passed by this Bench on the previous hearing.
- 2. The case has been heard today in Commission's office. The Complainant Ms. Kadambini comes present to attend the hearing through cisco webex. She states that a tender was floated by Municipal Council, Sri Muktsar Sahib for sterilisation of A.B.C. category dog and the same was allotted at very high rate. She had made a complaint in this regard, enquiry into which was got conducted by the Local Government Department, Punjab and she has sought copies of documents relating to this complaint/ enquiry and she has received only a letter stating it to be tender cancellation letter, which is actually not so. She still reiterates her statement made previously that she smacks of a big financial scam in this tender as the tender has again been allotted to an incapable and incompetent company.
- 3. Shri Vipin Kumar, Executive Officer and Shri Vikram Dhuria, Superintendent, M.C. Sri Muktsar Sahib, come present in person before the Bench to attend the hearing. The Executive Officer Shri Vipin Kumar states that neither the copy of complaint made by the complainant has been received nor any enquiry was conducted into this regard. So far as the version of complainant that enquiry was conducted by Mr. Shergill, he had only visited the Municipal Council and no enquiry was conducted nor his statement was recorded. He further stated that the letter sent to the complainant is the cancellation of tender allotted by the Municipal Council.
