**ORDERS**

This order may be read with reference to the previous order dated 06.05.2021 vide which the appellant was not present.

2. Today the appellant is appearing in the Commission office.

4. After hearing the appellant and examining the case file it is observed that the appellant has filed RTI on 24.09.2018, but after lapse of more than two and a half year, no information has been given to him so far, which shows that the respondent-PIO has no regard for the orders issued by the Commission. This is indeed a serious matter.
5. In view of the above, **PIO- EO, Nagar Palika , Kharar** is directed to show cause in writing or through affidavit under Section 20(1) of the RTI Act, as to why penalty be not imposed upon him for willful delay/ denial of the information to the RTI applicant and why the compensation be not awarded to the complainant under Section 19 (8)(b) of the Act for detriment suffered.
