O R D E R

Shri Mohammad Anwar (Ansari), complainant/applicant filed RTI application dated 23.10.2020 before the Deputy Commissioner, Sangrur. The RTI application was transferred U/s 6(3) of the RTI Act, 2005 to the SPIO, O/o DDPO, Sangrur vide letter dated 06.11.2020. Then again the RTI application was transferred U/s 6(3) of the RTI Act, 2005 to the SPIO, O/o BDPO, Malerkotla-1, Distt. Sangrur vide letter dated 13.11.2020.

Today the case is heard through CISCO Webex Meetings Software.

The complainant-applicant is present today, whereas none has come present on behalf of the SPIO. The complainant-applicant stated that in compliance to the Order dated 16.06.2021 he has visited the office of the PIO, but the sought for information has not been provided to him.

The SPIO is absent today and neither he has provided the sought for information to the appellant. The conduct of the SPIO is not fair and condemnable, which shows denial of information and defiance of the provisions of the RTI Act, 2005. So, a **show cause notice** is issued to Ms. Pinki Garg, SPIO-cum-BDPO, Malerkotla-1, Distt. Sangrur that why the complete sought for information has not been provided to the applicant within the stipulated period and so why she may not be penalized upto Rs. 25,000/- under the provisions of RTI Act, 2005.

The SPIO is directed to file written reply to the show cause notice and send the same to the Commission atleast 10 days before the next date of hearing and an opportunity of personal hearing will be afforded to her on the next date of hearing.

The SPIO is further directed to file reply to the complaint filed by the complainant-applicant and send the same to the Commission as well as to the complainant-applicant within 15 days and the SPIO is also directed to send the amount of compensation of Rs. 2,000/- by way of demand draft to the applicant through registered post within 15 days and compliance be sent to the Commission accordingly.
