ORDER

Sarabjit Singh Brar, Block Development and Panchayats Officer-cum-Public Information Officer to pay the compensation amounting to Rs.5000/- (Rupees five thousands only) to the appellant from the state exchequer to be payable by the office of the Block Development and Panchayats Officer failing which punitive action will be initiated on the next date of hearing.

2.
