Shri Rajwinder Singh, appellant filed RTI application dated 16.12.2019 and sought some information from the PIO, O/o Social Security and Women and Child Development Department, Amritsar.

The Commission has received a mail sent by the PIO on 24.08.2020, diarized vide no.10473, which is a copy of letter no.156 dated 18.08.2020 along with a photocopy of postal receipt dated 14.08.2020. I have gone through the said letter and it is submitted by the PIO that the sought for information/reply has been sent to the appellant through registered post on 14.08.2020.

The PIO has also sent an e-mail to the Commission, which is a copy of letter no.149 dated 13.08.2020 through which the sought for information/reply was sent to the appellant. I have gone through the said letter and the PIO has replied each and every para of the RTI application.

The appellant stated that he has received the information which was sent to him by the PIO.

As the sought for information/reply has been sent to the appellant through registered post on 14.08.2020 and the appellant has received the information, so the present appeal case is **disposed of and closed.**

O R D E R

Shri Ravinder Pal Singh Chaddha, appellant filed RTI application dated 24.12.2019 and sought some information from the PIO, O/o Municipal Corporation, Jalandhar. When no information was provided to him by the PIO, then he filed First Appeal before the First Appellate Authority on 27.01.2020. Then he filed Second Appeal before the Punjab State Information Commission on 23.06.2020. The case was registered and allocated to the Bench. Notice of hearing was issued to both the parties for today **through CISCO Webex Meetings Software.**

The appellant is present today, whereas none has appeared on behalf of the PIO.

I have gone through the RTI application dated 24.12.2019 filed by the appellant. The appellant has not mentioned the name of the owner of the building or the description of the building for which he is seeking information. Therefore, the information sought by the appellant through his RTI application is not specific rather it is vague and hence is being dismissed.

As the information sought by the appellant through his RTI application is not specific rather vague, so the present appeal case is **disposed of and closed.**
