ORDER:

The appellant through RTI application dated 16.09.2019 has sought information regarding property tax collected against the properties falling under the jurisdiction of NC FAzilka, number of divisions for collecting property tax, rate of tax and other information concerning the office of EO-MC Fazilkia. The appellant was not provided the information after which the appellant filed first appeal before the First Appellate Authority on 23.10.2019 which directed the PIO to supply information by 05.12.2019 and appear before the First Appellate Authority on 06.12.2019.

The case came up for hearing today through video conferencing at DAC Fazilka. The appellant claimed that the PIO has not provided the information. The respondent was absent.

It was observed that the PIO had neither contacted to the appellant nor attended the hearing of the First Appellate Authority as seen in the order of the First Appellate Authority and neither made himself/herself present at the Commission's hearing.

Having gone through the record on the file, it was found that there has been constant break down of the implementation of the RTI Act. The PIO was issued a show cause notice under Section 20 of the RTI Act 2005 and directed to file reply on an affidavit. The PIO was again directed to provide the information to the appellant within 10 days of the receipt of the order.

Hearing dated 01.09.2020:

The case has come up for hearing today through video conferencing at DAC Fazilka. As per appellant, the PIO has not supplied the information.

At the last hearing, the PIO was issued a show cause notice for not attending to the RTI application within the time prescribed under the RTI Act and constant breakdown of the implementation of the RTI Act. The PIO was directed to file written reply to the show cause notice on an affidavit. The PIO was also directed to provide the information to the appellant within 10 days of the receipt of the order.

Appeal Case No. 444 of 2020

The PIO is absent on 2nd consecutive hearing nor has complied with the order of the Commission.

Keeping the above-mentioned facts of the case, it is clear that the PIO-EO-MC, Fazilka is flouting the spirit of the RTI Act continuously. The PIO has not only shown utter disregard for the Commission's repeated orders to provide the information but has shown willful stubbornness in not replying to the Show Cause and not appearing before the commission despite various orders of the Commission.

To secure an erring PIO's presence before the commission the Information Commission is empowered to issue warrants to Under Section 18(3) of the RTI Act. A bailable Warrant of the PIO-Estate Officer, MC Fazilka is hereby issued through Senior Superintendent of Police, Fazilka for his presence before the Commission on **13.10.2020**.

The case is adjourned. To come up for further hearing on 13.10.2020 at 11.00 PM through video conference facility available in the office of Deputy Commissioner, Fazilka. The PIO to appear at Chandigarh.

The PIO-Tehsildar, Moga and both the 3rd parties were absent. The appellant was absent and vide email had submitted his written submission which was taken on the file of the Commission.

The PIO-Tehsildar, Moga was given one last opportunity to comply with the earlier order of the Commission and provide the information on Points-2 & 8. The PIO was also directed to be present on the next date of hearing. Both the 3rd parties were also given one last opportunity to appear before the Commission and plead their case.

Appeal Case No. 3615 of 2018

On the next date of hearing on **24.02.2020**, the appellant was absent and vide email has informed that he has not received the information regarding point-3 from the office of SDM Moga as recorded in the last order. The appellant further informed that he has not received information on other points also. A copy of the information regarding point-3 submitted by the respondent at the hearing on 19.12.2019 was attached with the order for the appellant.

The PIO-SDM Moga was absent. The PIO-Tehsildar Moga was also absent and vide email has sought adjournment on the plea that they have been deputed by the SDM to attend Mahatma Gandhi Sarbat Vikas Yojna camp to be organized on 24.02.2020 at Ghal Kalan.

Sh.Gurmukh Singh, the 3rd party was present and pleaded that his file relating to his assessment be not provided. The case was adjourned.

On the last date of hearing on **07.07.2020, which** was held through video conferencing at DAC Moga. The respondent present from the office of SDM pleaded that the information regarding point-3 has already been provided. The appellant is absent and vide email has informed that he has received the information on point-3 but the information on points-2 & 8 has not been supplied.

The PIO-Tehsildar Moga was absent. The respondent present from the office of Tehsildar Moga sought some more time and assured to supply the information on points-2 & 8 within 10 days.

The PIO-Tehsildar Moga was directed to supply the information on points-2 & 8 within 10 days and send a compliance report to the Commission.

Hearing dated 01.09.2020:

The case has come up for hearing today through video conferencing at DAC Moga. Both the parties are absent. The appellant vide email has informed that the discrepancies in the information has been pointed out to the PIO O/o Tehsildar Moga vide email dated 16.07.2020 with a copy to the Commission. The appellant has further informed that he contacted Mr.Mangaljit Singh, Reader to the Tehsildar Moga who informed that the entire staff had been on strike and had requested for some more time to provide the information. The appellant states that he has no objection if the Hon'ble Court grants additional time to the PIO to provide the complete point-wise information.

The earlier order stands. The case is adjourned. The PIO is directed to sort out the discrepancies as pointed out by the appellant via email dated 16.07.2020.

To come up for further hearing on **21.10.2020 at 11.00 AM** through video conference facility available in the office of Deputy Commissioner, **Moga.** The appellant may appear at Chandigarh.
