**ORDER** 

The RTI application is dated 26.11.2020 vide which the appellant has sought information as enumerated in his RTI application. 2. The appellant has sought the following information:-

- 3. The representative of the respondents states that the reply has already been sent to the Commission with a copy to the Complainant, which is taken on record. Also the relevant portion of the same is reproduced below:-

- 4. Keeping in view the submission made by the respondent, the Commission observes that no further action is required to be taken in this case. Hence, the case is disposed of and closed. Copy of the response received from the respondent is being **sent** to the appellant along with this order.

ORDER
