The respondents say that he is habitually and regularly seeking repetitive information, which is usually humongous. Invoking the provisions of Section 7(9) of the RTI Act, the respondents say that it shall erode the resources disproportionately. The Commission is inclined to accept their version. The Commission finds it motivated and counterproductive and is not inclined to intervene into the matter. The appeal is **dismissed**.
