The Respondent-PIO states that the sought for information has already been supplied to the appellant on 25.03.2019.

2. The appellant is present in the court and states that the supplied information is incomplete.
3. The Respondent-PIO is directed to supply the remaining information relating to point No.1(c) and point No.3 before the next date of hearing. She is further directed to be present in the court along with a copy of above remaining information on the next of hearing.
4. Adjourned and to come up **on 27.11.2019 at 11.30AM**. Copy of order be sent to the parties.
